- 3. You'll get an email with a new link (check Spam if you don't see it right away).
- 4. Click that and you'll get a form where you can confirm your US Mail and email preferences. Make any necessary edits.
- 5. Be sure that the "Yes, receive email updates" preference is selected.
- 6. Click SAVE if you make any changes.
